Subthemes

This Subtheme would combine different goals into one focused area. The goals that propose to end poverty in all its forms everywhere, end hunger, achieve food security, Improve nutrition, promote sustainable agriculture, ensure healthy lives, promote well-being for all at all ages, and conserve and sustainably use the oceans, seas and marine resources for sustainable development form a part of this sub theme.

Subtheme II Ensuring Sustained Development: Public Policies Towards Greener Planet

This Sub theme combines all the goals that are directed towards affordable, reliable, sustainable and modern energy, building of resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation,making cities and human settlements inclusive, safe, resilient and sustainable, ensuring sustainable consumption and production patterns and taking urgent action to combat climate change and its impacts are included in this subtheme. In addition, the goal to protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, halt and reverse land degradation and halt biodiversity loss also forms a part of the above.

Sub theme III Sustainable Development: Equitable and Inclusive

In this subtheme all the goals that are directed towards ensuring inclusion are considered. Inclusive and equitable quality education, promotion of lifelong learning opportunities for all, achieving gender equality, ensuring full and productive employment, decent work for all, reducing inequality within and among countries, promoting peaceful and inclusive societies for sustainable development, provide access to justice for all, protecting human rights of all and build effective, accountable and inclusive institutions at all levels and strengthen the means of implementation and revitalize the global partnership for sustainable development are all the aspects that can be discussed under this sub theme.
